Subject:	Draft DIRECTIVE OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL laying down specific rules with respect to Directive 96/71/EC and Directive 2014/67/EU for posting drivers in the road transport sector and amending Directive 2006/22/EC as regards enforcement requirements and Regulation (EU) No 1024/2012 (first reading)

- On 31 May 2017 the <u>Commission</u> sent its proposal<sup>1</sup>, based on Article 91(1) TFEU, to the Council.
- 2. The European Economic and Social Committee delivered its opinion on 18 January 2018<sup>2</sup>.
- 3. The <u>Committee of the Regions</u> delivered its opinion on 1 February 2018<sup>3</sup>.
- 4. The <u>European Parliament</u> adopted its position at first reading on 4 April 2019<sup>4</sup>.

- On 20 February 2020, the <u>Council</u> reached a political agreement on the Council's position at first reading on the above draft Directive<sup>5</sup>.
- 6. On 20 March 2020, the <u>Permanent Representatives Committee</u> agreed to suggest that the Council adopt its position at first reading. The text of the Council's position at first reading<sup>6</sup> is available in all official languages of the European Union, as well as the statement of reasons set out in the addendum to the Council's position at first reading.
- 7. In absence of Council meetings and in view of the above, the <u>Permanent Representatives</u> <u>Committee</u> is invited to decide, in accordance with the first subparagraph of Article 12(1) of the Council's Rules of Procedure and Article 1 of Council Decision 2020/430, that the Council uses the written procedure:
  - for the adoption of its position at first reading on the draft Directive of the European Parliament and of the Council amending Directive 2006/22/EC as regards enforcement requirements and laying down specific rules with respect to Directive 96/71/EC and Directive 2014/67/EU for posting drivers in the road transport sector as set out in document 5112/20 and the Statement of reasons as set out in document 5112/20 ADD 1.
