COMMISSION COMMUNICATION TO THE COUNCIL

Extension of the Cooperation Agreement between the European Atomic Energy Community and the Kingdom of Spain in the field of controlled thermonuclear fusion.

On 14 July 1980 the Commission concluded the above-mentioned Agreement, in accordance with the second paragraph of Article 101 of the Euratom Treaty.

Under the Agreement Spain participates in the contracts to promote staff mobility concluded by the Commission and its associates in the field of controlled thermonuclear fusion.

The Agreement was concluded for a period of three years, corresponding to the fifth Euratom research and training programme in the field of controlled thermonuclear fusion (1979-83), and will expire on 13 July.

When the mixed Euratom/Spain Fusion Committee set up under the Agreement to monitor implementation met on 27 May 1983, the Spanish representatives proposed that the Agreement be extended. The Commission representatives agreed to the proposal, and promised to seek the Council's approval.

At a meeting on 19 April 1983 the Advisory Committee on Fusion returned a favourable opinion on extension of the Agreement.

Accordingly, the Commission herewith sends the Council (a) a draft decision on directives to the Commission for negotiating the extension of the Agreement and (b) a draft decision approving the extension of the Agreement by the Commission.

COUNCIL DECISION (EURATOM)

on directives to the Commission for negotiating the extension of the Cooperation Agreement between the European Atomic Energy Community and the Kingdom of Spain in the field of controlled thermonuclear fusion

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Atomic Energy Community, and in particular the second paragraph of Article 101 thereof,

Having regard to the Cooperation Agreement between the European Atomic Energy Community and the Kingdom of Spain in the field of controlled thermonuclear fusion concluded on 14 July 1980 for a period of three years,

Having regard to the draft Decision submitted by the Commission,

Whereas on 25 May 1982 the Council adopted a sixth Euratom research and training programme in the field of controlled thermonuclear fusion for the period 1982-86,

HAS DECIDED AS FOLLOWS :

Sole Article

The Commission shall negotiate the extension of the Cooperation Agreement between the Community and the Kingdom of Spain in the field of controlled thermonuclear fusion. The Agreement may not be extended for a period going beyond the lifetime of the Community's current research and training programme in the field of controlled thermonuclear fusion.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Atomic Energy Community, and in particular the second paragraph of Article 101 thereof,

Having regard to the Cooperation Agreement between the European Atomic Energy Community and the Kingdom of Spain in the field of controlled thermonuclear fusion concluded on 14 July 1980 for a period of three years,

Having regard to the draft Decision submitted by the Commission,

Whereas on 25 May 1982 the Council adopted a sixth Euratom research and training programme in the field of controlled thermonuclear fusion for the period 1982-86;

Whereas the Commission has negotiated the extension of the said Cooperation Agreement in the field of controlled thermonuclear fusion, pursuant to directives laid down by the Council;

Whereas it is necessary to approve the extension by the Commission of the said Agreement for the lifetime of the said sixth programme,

HAS DECIDED AS FOLLOWS :

Sole Article

The extension until 31 December 1986 of the Cooperation Agreement between the European Atomic Energy Community and the Kingdom of Spain in the field of controlled thermonuclear fusion is hereby approved.
