**COUNCIL DECISION**

**Concerning the renewal of the Agreement for scientific and technological cooperation  
between the European Community and Ukraine**

## EXPLANATORY MEMORANDUM

1. The Agreement on cooperation in science and technology between the European Community and Ukraine was signed in Copenhagen on 4 July 2002 and entered into force on 11 February 2003. Article 12 (b) of the Agreement provides as follows: "This Agreement shall be concluded for an initial period ending on 31 December 2002 and will be renewable by common agreement between the Parties for additional periods of five years".
2. By Council Decision 2003/737/EC of 22 September 2003<sup>1</sup> the Agreement was renewed for a further period of five years which entered into force on 8 November, 2004. The Agreement is due to expire on 7 November, 2009.
3. It is in the interest of the Community to renew this Agreement in order to continue to facilitate cooperation with Ukraine in common S&T priority areas leading to socio-economic benefits for both Parties.
4. Both Parties confirmed their intention to renew the agreement at the 3<sup>rd</sup> meeting of the EU-Ukraine Sub Committee N° 7, held in Kyiv on 26 and 27 November, 2008.
5. The material content of the renewed Agreement will be identical to the material content of the current Agreement.
6. In the light of the above considerations, the Commission requests the Council:
  - to approve, on behalf of the Community, after consulting the European Parliament, the renewal of the Agreement for scientific and technological cooperation between the European Community and Ukraine for an additional period of five years;
  - to express the consent of the Community to be bound by the Agreement's provisions.

**COUNCIL DECISION**

**Concerning the renewal of the Agreement for scientific and technological cooperation between the European Community and Ukraine**

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, and in particular the second paragraph of Article 170 thereof in conjunction with the first sentence of the first subparagraph of Article 300(2), and the first subparagraph of Article 300(3),

Having regard to the proposal from the Commission<sup>2</sup>,

Having regard to the opinion of the European Parliament<sup>3</sup>,

Whereas:

- (1) By its Decision 2003/96/EC of 6 February, 2003<sup>4</sup>, the Council approved the conclusion of the Agreement for scientific and technological cooperation between the European Community and Ukraine.
- (2) Article 12 (b) of the Agreement provides as follows: "This Agreement shall be concluded for an initial period ending on 31 December 2002 and will be renewable by common agreement between the Parties for additional periods of five years".
- (3) By its Decision of 22 September, 2003<sup>5</sup> the Council approved the renewal of the Agreement for a further period of five years which entered into force on 8 November, 2004.
- (4) At the 3<sup>rd</sup> meeting of EU-Ukraine Sub-Committee N° 7, held on 26 and 27 November, 2008 in Kyiv both Parties confirmed their interest in a renewal of the abovementioned Agreement for another five years.
- (5) The material content of the renewed Agreement will be identical to the material content of the Agreement which expires on 7 November, 2009.
- (6) The renewal of the Agreement for scientific and technological cooperation between the European Community and Ukraine should be approved on behalf of the Community.

*Article 1*

The renewal of the Agreement for scientific and technological cooperation between the European Community and Ukraine, for an additional period of five years is hereby approved on behalf of the Community.

*Article 2*

The President of the Council shall, acting on behalf of the Community and in accordance with point (b) of Article 12 of the Agreement, give the notification to the Government of Ukraine that the Community has completed its internal procedures necessary for the entry into force of this renewed Agreement.

*Article 3*

The decision shall be published in the Official Journal.

**5. CHARACTERISTICS AND OBJECTIVES**

**5.1. Need to be met in the short or long term**

This decision will allow both Parties to continue, upgrade and intensify their cooperation in areas of common scientific and technological interest.

**5.2. Value-added of Community involvement and coherence of the proposal with other financial instruments and possible synergy**

This Agreement is based on the principles of mutual benefit, reciprocal opportunities for cooperation activities such as joint or coordinated calls for joint projects, access to each other's programmes and activities relevant for the purpose of the Agreement and the effective protection of intellectual property and equitable sharing of intellectual property rights. The proposal also provides for missions by EU experts and officials, and for workshops, seminars and meetings to be organised in the European Community and in Ukraine.

The cooperative activities in the field of science and technology under this agreement are complementary to and in support of other Community activities vis à vis Ukraine. As set out in the draft EU-Ukraine Association Agreement, it is foreseen that co-operation between the Parties shall aim at facilitating the increasing involvement of the Ukraine into the European Research Area. Such cooperation shall assist Ukraine to support the reform and reorganisation of its science management system and research institutions (including the development of its capacity in research and technological development) in order to support the development of a competitive economy and knowledge society.

**5.3. Objectives, expected results and related indicators of the proposal in the context of the ABM framework**

This decision should allow both Ukraine and the European Community to derive mutual benefit from the scientific and technical progress achieved through their specific research programmes. It will allow an exchange of specific knowledge and a transfer of know-how to the benefit of the scientific community, industry and citizens.

As set out in the draft EU-Ukraine Association Agreement, it is foreseen that co-operation shall take place particularly through:

Exchange of information on each other's science and technology policies;

Participation in the Framework Programme of the European Community (EC) for research and technological development;

Joint implementation of scientific programmes and research activities;

Joint research and development activities aimed at encouraging scientific progress and the transfer of technology and know-how;

Training through mobility programme for researchers and specialists;

The organisation of joint scientific and technological development events/measures;

Implementation measure aimed at the development of an environment conducive to research and the application of new technologies and adequate protection of the intellectual property results of research;

Enhancement of co-operation at regional and international level notably in the Black Sea context and within multilateral organisations such as UNESCO, OECD and G8, as well as in the context of multilateral agreements such as the UN Framework Convention on Climate Change;

Exchange of expertise on management of research and science institutions in order to develop and improve their capacities of conducting and participation in scientific researches.

## **6. MONITORING AND EVALUATION**

The Commission departments will regularly monitor all the actions carried out under the cooperation agreement, which will also be subject to a joint regular evaluation by the Community and Ukraine.

#### **Evaluation**

The Commission will evaluate the actions covered by this cooperation agreement before the end of the five year implementation period. This evaluation will cover:

- number of missions and meetings;

*6.1.3. Terms and frequency of future evaluation*

The Parties to the Agreement will evaluate the application thereof annually in the meetings of the Joint Community-Ukraine Committee referred to in Article 6 thereof. Further renewal of this agreement will be submitted for assessment by each of the Parties.

## **7. ANTI-FRAUD MEASURES**

When the implementation of the framework programme calls for the use of external contractors or implies granting financial contributions to third parties, the Commission will carry out, where appropriate, financial audits, in particular if it has reason to doubt the realistic nature of work performed or described in the activity reports.

The Community's financial audits will be carried out either by its own staff or by accounting experts approved according to the law of the audited party. The Community will choose the latter freely, while avoiding any risks of conflicts of interest which might be indicated to it by the party subject to the audit.

In addition, in carrying out the research activities, the Commission will ensure that the financial interests of the European Communities are protected by effective checks and, where irregularities are detected, by proportionate and dissuasive measures and penalties.

In order to achieve this aim, rules on checks, measures and penalties, with references to Regulations No 2988/95, 2185/96, 1073/99 and 1074/99 will be set out in all contracts used in the implementation of the framework programme.

In particular, the following points will have to be provided for in the contracts:

- the introduction of specific contractual clauses to protect the financial interests of the EC in carrying out checks and controls in relation to the work performed;
- the carrying out of administrative checks as part of anti-fraud measures, in accordance with Regulations No 2185/96, No 1073/1999 and No 1074/1999;

- the application of administrative penalties for all intentional or negligent irregularities in the implementation of the contracts, in accordance with the framework Regulation No 2988/95, including a blacklisting mechanism;
- the fact that possible recovery orders in case of irregularities and fraud be enforceable according to Article 256 of the EC Treaty.

In addition and as routine measures, an internal audit and control programme in respect of scientific and budgetary aspects will be carried out by the DG Research staff responsible; an internal audit will be carried out by the Internal audit Unit of DG Research; and local inspections will be undertaken by the Court of Auditors of the European Union.
